## SAFe Training Course with Product Owner/Product Manager Certification

### Exam Details

- **Exam name:** SAFe® 4 Product Owner/Product Manager Exam
- **Exam format:** Multiple choice
- **Exam delivery:** Web-based (single-browser), closed book, no outside assistance, timed
- **Exam access:** Candidates can access the exam within the SAFe Community Platform upon completion of the SAFe 4 Product Owner/Product Manager course
- **Exam duration:** Once the exam begins, candidates have 90 minutes (1.5 hours) to complete it
- **Number of questions:** 45
- **Passing score:** 35 out of 45 (77% passing score)
- **Language:** English
- **Exam cost:** First exam attempt is included as part of the course registration fee if the exam is taken within 30 days of course completion. Each retake attempt costs \$50.
- **Retake policy:** Second attempt on exam (first retake) can be done immediately after first attempt. Third attempt requires a 10-day wait. Fourth attempt requires a 30-day wait. Contact [support@scaledagile.com](mailto:support@scaledagile.com) for any retake questions.

### Professional Development Units (PDUs) and Scrum Education Units (SEUs)

- ✓ Attendees may be eligible to apply for 15 PDUs toward their continuing education requirements with the Project Management Institute (PMI) for PMP, PgMP, and PMI-ACP certifications.
- ✓ Attendees may be eligible to apply for SEUs under category C, toward earning or renewing their CSP through Scrum Alliance.
